Privacy Policy

1. INTRODUCTION

Kablor Projects (Pty) Ltd (Kablor Projects) recognizes the importance of privacy and the protection of personal information provided to it and is committed to the safeguarding of such information.

This privacy policy explains how Kablor Projects collects and uses personal information. It contains information regarding the rights of natural and juristic persons to whom personal information relates (data subjects).

Kablor Projects reserves the right to amend this Privacy Policy or add provisions to it at any time by publishing an updated version on its website.

2. COLLECTION OF INFORMATION

Kablor Projects collects personal information in various instances, including when:

- data subjects contact Kablor Projects or request information or services;
- Kablor Projects provides services to data subjects;
- persons apply for employment at Kablor Projects;
- when persons use Kablor Projects's websites or engage with Kablor Projects through social media.

The interaction with Kablor Projects on Kablor Projects 's website will result in the collection of information regarding the person's activities on the website. Similarly, when anyone engages with Kablor Projects via any one of Kablor Projects's social media platforms. This information includes, but is not limited to, the person's name, contact details and information regarding the matter with which they need assistance.

In the course of engaging with clients on matters, Kablor Projects will naturally be exposed to and collect personal information which includes the data subject's name and contact details as well as information regarding the matters that we need to assist them with.

As part of its recruitment processes, Kablor Projects collects information from graduates and employment applicants. This information includes educational information as well as employment history. By enquiring regarding employment opportunities at Kablor Projects or applying for employment, applicants are deemed to provide their consent to Kablor Projects's processing of their personal information for recruitment purposes, which may include screening as well as background and reference checks.

3. BASIS AND PURPOSE FOR ROCESSING PERSONAL INFORMATION

Kablor Projects may process personal information:

- to provide services to clients;
- to comply with legal or regulatory obligations;
- if a data subject has provided their consent; or
- if the processing is allowed by law.

The purposes for which Kablor Projects processes personal information include, but are not limited to:

- marketing and promotion of Kablor Projects's services;
- providing and improving services to clients;
- improving users' experience when using Kablor Projects's websites;
- communicating with persons for Kablor Projects's internal purposes;
- enabling Kablor Projects's internal operations;
- exercising and defending legal rights.

4. DISCLOSURE OF PERSONAL INFORMATION

Kablor Projects may release personal information or disclose it to third parties in certain circumstances. These include, but are not limited to:

- if Kablor Projects is required or authorised to do so by law or a court order;
- in order for Kablor Projects to enforce its rights;
- in order for Kablor Projects to provide services to its clients.

The third parties to whom we disclose personal information include, but are not limited to:

- advocates and other parties involved in legal services;
- third party service providers to Kablor Projects or its clients;
- third parties who provide research services to Kablor Projects or its clients;
- government authorities and registries, organs of state, regulators, courts, tribunals and law enforcement agencies.

5. TRANSFER OF PERSONAL INFORMATION

Personal information collected by Kablor Projects may be transferred to persons in other countries. Those countries' laws might not protect personal information in the same way or on the same level as the law in the data subject's country. However, Kablor Projects will take reasonable steps to ensure that recipients in other countries have appropriate privacy measures in place.

6. RETENTION OF PERSONAL INFORMATION

Kablor Projects retains personal information for as long as may be reasonably necessary in accordance with applicable law.

7. COOKIES

Kablor Projects websites makes use of cookies. Cookies store information regarding website visitors. Cookies have various purposes, such as improving the visitor's experience on the website and facilitating their use of the website.

8. DIRECT MARKETING

Kablor Projects may send marketing and promotional communications and material to persons. Recipients may opt out from receiving such communications by contacting Kablor Projects at the details provided below or by clicking on the opt-out link that will be contained in the relevant electronic communication.

9. SECURITY

Kablor Projects takes all reasonable steps to protect and avoid unauthorised access to personal information. It has implemented various policies, procedures, and software to safeguard personal information and routinely reviews its operations in order to ensure that personal information is adequately protected.

10.DATA SUBJECT RIGHTS

The law might provide data subjects with rights to access, amend or delete personal information that is in the possession of Kablor Projects. However, Kablor Projects may, in certain instances, legally refuse or decline such requests. If applicable, a data subject may also have the right to object to Kablor Projects's processing of their personal information or to file a complaint with a regulator. If a data subject wishes to exercise their rights, they can contact Kablor Projects at the details provided below. Kablor Projects may charge data subjects a fee for accessing, amending or deleting their personal information.
